

**Notice of Nominations,  
JetBlue IFC Election and Campaign Rules

The Transport Workers of Union of America, AFL-CIO (“TWU International”) is responsible for ensuring the Local 579 election is conducted in accordance with the TWU Constitution and Title IV of the Labor-Management Reporting and Disclosure Act of 1959, (“LMRDA”), and, in accordance with this responsibility, has established the following rules for this election:

**1. Election Liaison**

TWU International Vice President Thom McDaniel will act as the Liaison for the election and any questions, correspondence, or protests should be directed to [579election@twuatd.org](mailto:579election@twuatd.org).

**2. Election of Union Officials**

The inaugural nomination and election of the Transport Workers Union of America, Local 579 Officers and Executive Board will be conducted in accordance with the 2021 edition of the TWU International Constitution and the LMRDA.

The following positions will be on the ballot:

- a. President,
- b. Vice President,
- c. Recording Secretary,
- d. Financial Secretary-Treasurer,
- e. One (1) Executive Board Member at Large,
- f. Six (6) Base Executive Board Members – One Base Executive Board Member will be elected for BOS, EWR, FLL, JFK, LAX, and MCO by those eligible members at each Base.

In addition, the election of Delegate(s) and Alternate(s), as needed, for the 27<sup>th</sup> TWU International Convention will be conducted simultaneously.

**3. Term of Office**

Candidates elected to office will have a three-year term to begin on **November 1, 2022** until the next scheduled Officer and Executive Board election and installation on **November 1, 2025**.

**4. Eligibility to Nominate and/or Run for Office**

To be eligible to nominate and to run for election to office, a Member must be in good standing. To be a Member in good standing for the purpose of this election, you must:

- 1. Have submitted your forms for dues checkoff **no later than August 18, 2022 at 11:59 P.M. Pacific**; or

2. Requested and have been approved an exoneration for the months of June and July 2022; or
3. If you have done neither 1 nor 2, TWU International must receive your dues payments for the months of June and July 2022 in full **prior to August 15, 2022**. The mailing address for such payments is: Transport Workers Union of America, 300 State Street, Box 93060, Southlake, TX 76092-9998.

Section 504 of the LMRDA prohibits persons convicted of certain crimes, including robbery, bribery, extortion, embezzlement, grand larceny, burglary, arson, violation of narcotics laws, murder, rape, assault with intent to kill, assault which inflicts grievous bodily injury and violations of Title II of the LMRDA, from holding office for thirteen (13) years after conviction or after their release from imprisonment, whichever is later.

## **5. Nomination Form**

The Official Local 579 Nomination Form will be made available on the [Local 579 website](#) prior to the opening of nominations.

## **6. Nominations**

Any Transport Workers Union of America Local 579 Member in good standing may nominate themselves or another Transport Workers Union of America Local 579 Member in good standing for the position of President, Vice President, Recording Secretary, Financial Treasurer, Executive Board Member At-Large, Base Executive Board Member, and/or Convention Delegate.

Delegates to the International Convention shall be in the order below and as required:

- President,
- Vice President,
- Recording Secretary,
- Financial Secretary-Treasurer,
- Executive Board Members (In order of votes, high to low)

Additional delegates and alternate delegates to the 27<sup>th</sup> TWU International Convention will also be nominated and elected in this election cycle. The final number of delegates to the Convention will be based on the number entitled to per the TWU International Constitution, in the order of votes, highest to lowest.

Nominations for all positions in Section 2 listed above will open at **9AM Pacific on August 19, 2022**.

Nominations for all positions in Section 2 listed above will close at **9AM Pacific on August 26, 2022**.

TWU International will review Union records to verify the eligibility of all nominees. TWU will advise each non-eligible nominee of the determination via email on file with the Union.

Each Member nominated will be contacted via email on file with the Union to accept or decline their nomination. Each nominee will have until **9AM Pacific on August 29, 2022**, to accept or decline their nomination, via email to [579election@twuatd.org](mailto:579election@twuatd.org). If no email response is provided before the deadline, the nomination will be considered as declined. Any acceptance of nomination submitted after **9AM Pacific on August 29, 2022**, will be deemed null and void.

If a Member is nominated for more than one Officer and/or Executive Board position, the e-mail will list the nominations and the Member is required to designate the position they wish to run for.

In the event only one Member is nominated to a position, that candidate shall be deemed elected by acclamation and no further vote is required.

#### **7. Further Election Rules**

No Member of Transport Workers Union of America Local 579 shall be permitted to run for more than one Officer and/or Executive Board position. Any member running for an Officer or Executive Board position is also eligible to run for the Convention Delegate position.

Anyone elected as an Officer or Executive Board Member will be deemed an ex-officio delegate to the Convention. Any Local 579 Officer or Executive Board Member who is deemed as ex-officio to the Convention, will be stricken from the delegate election.

#### **8. Placement on the Ballot**

Names of candidates running for in this election will be listed on the ballot in alphabetical order by their last name.

#### **9. Inspection of the Membership List**

The Membership list will be available for view and inspection by any candidate on **August 31, September 1, and 2, 2022, between the hours of 9AM Central to 3PM Central**, at the following location:

No candidate is entitled to copy or receive a copy of the Membership list; nor will any candidate be compensated for lost time or travel expenses to view the Membership list.

**10. Distribution of Campaign Literature**

Each candidate will have the opportunity to send campaign literature to the Membership. Distribution will be at the candidate's expense and must be pre-paid. Access to this process will be available after all candidates who accept their nomination are finalized. Use of the TWU International logo on any campaign material is strictly prohibited.

**11. Campaign Restrictions**

Section 401(g) of the Labor-Management Reporting and Disclosure Act of 1959 prohibits the use of union and employer funds to promote the candidacy of any person in a union officer election. This prohibition applies to facilities, equipment, supplies, and cash, as well as to campaigning on time paid for by either a union or employer. These restrictions include:

1. A union or employer may not contribute money or anything of value to promote the candidacy of any individual in a union officer election.
2. The prohibition against the use of union and employer funds applies to any union and any employer, not just to TWU Local 579 or to the employers with whom TWU International has collective bargaining agreements. For example, it is improper for a candidate to have campaign literature duplicated free of charge on a copy machine at a friend or relative's employer.
3. Any expenditure of union or employer funds on behalf of a candidate, even if the amount is small, is a violation of federal law.
4. The use of union or employer funds or facilities is a violation of federal law even if union officials or the employer do not know about or approve of the use.
5. The prohibition against the use of union and employer funds applies to direct expenditures from the union or employer and indirect expenditures such as:
  - Campaigning on time paid for by the union or employer
  - Use of union or employer-owned, leased, or paid for by the union, equipment, such as telephones, fax machines, computers, copy machines, email accounts and vehicles
  - Use of union or employer supplies such as stamps, paper, and

envelopes

- Use of union employees to prepare campaign literature while on union time
  - Use of the union letterhead, logo, or Membership list
  - Use of union or employer property or facilities to conduct campaign activities, store campaign material or distribute campaign material
  - Printing articles which support or criticize an individual's candidacy in a union newspaper or other publication
  - Giving free services or special discounts to a candidate such as printing, photocopying, equipment rental, including business travel passes.
6. Federal law also provides that candidates must be treated equally regarding the opportunity to campaign and that all Members may support the candidates of their choice without being subject to penalty, discipline, or reprisal of any kind.

## **12. Voter Eligibility**

To be eligible to vote in the election, you must be a Member in good standing, as described in Rule #4 above. Members not in good standing, as described in Rule #4 above, and Agency Fee Objectors will not receive ballots or be eligible to vote.

Retirees are not eligible to vote.

## **13. Election Notice**

A notice of election will be mailed to the current home address on file with TWU International, no less than fifteen (15) days prior to the election. Election notices will also be posted on the TWU Local 579 website, [579twu.org](http://579twu.org).

## **14. Casting Ballots**

This election will be conducted by BallotPoint Election Services. Voting instructions and individual ballots will be mailed via U.S. Mail to the current home address on file with TWU International.

**15. Election Schedule**

**Ballots will be mailed out between October 3 - 4, 2022.** Voting will close on **October 28, 2022, at 10AM Central**; at that time the ballots will be picked up from the U.S. Postal facility and the counting will begin.

**16. Lost or Missing Voter Instructions & Access Credentials**

Those members who have not received their ballot **by October 13, 2022** should email TWU International Vice President, Thom McDaniel, at [579election@twuatd.org](mailto:579election@twuatd.org) to request a replacement ballot. Each member requesting a replacement ballot must include their name, employee number, current address, previous address if you have recently moved, and a cell phone number for positive contact to verify that you have requested a replacement ballot.

**17. Tally of Ballots**

The candidate who receives the highest number of votes for President, Vice President, Recording Secretary, Financial Secretary-Treasurer, Board Member at Large, and Base Executive Board Member will be deemed the winner of those respective elections. In the event of a tie, TWU International shall conduct a runoff election with only the two top vote getters as candidates. Any Member running unopposed shall be deemed elected to that office.

**18. Observers**

Each candidate may appoint one observer, at the candidate's own expense, to observe the receipt from the U.S. Postal facility, opening, and counting of the ballots. Observers must be a Member in good standing of TWU Local 579. Candidates are to submit the name of their observer in writing to [579election@twuatd.org](mailto:579election@twuatd.org) no later than **10AM Pacific on October 3, 2022**.

**19. Election Results**

TWU International will post the results of the election on the TWU Local 579 Website shortly after the election results are certified.

**20. Election Records**

TWU International will maintain all election records for at least 1 year after the completion of the election as required by federal law.

**21. Questions or Problems**

Any violation of these rules should be reported promptly to TWU International Vice President, Thom McDaniel, at [579election@twuatd.org](mailto:579election@twuatd.org) so that corrective action can be taken, if necessary.

**22. Protests**

Any Member in good standing who believes that he/she has been improperly denied the opportunity to be a candidate for an elective office or position may file a complaint with TWU International Vice President, Thom McDaniel, at [579election@twuatd.org](mailto:579election@twuatd.org), no later than 15 days after receiving notice of the denial.

Any Member in good standing who believes that an election in which he/she was a candidate was improperly conducted may file a complaint with TWU International Vice President, Thom McDaniel, at [579election@twuatd.org](mailto:579election@twuatd.org), no later than 15 days after the results of the election have been made known.

The decision of TWU International Vice President, Thom McDaniel may be appealed to the International Committee on Appeals within 15 days of the decision pursuant to Article XXII of the TWU International Constitution. If the TWU International Vice President, Thom McDaniel does not issue a decision within 30 days, the Member may also appeal to the International Committee on Appeals under Article XXII of the TWU International Constitution.

The above rules are not all inclusive. If necessary, additional election rules or clarifications may be issued by TWU International, as needed during the nomination and election period.
